CAES Fee Refund Policy (Academic Session 2025-26)

For all CAES programmes offered at Pearl Academy campuses, the fee refund will be applicable as per UGC guidelines, based on the last date of admission, i.e., 31st August 2025.

The refund criteria are as follows:

Criteria	% Fee Refund
If a student withdraws 15 days or more before the last date of admission i.e., before 16th August 2025.	100% Refund
If withdrawal is made within 15 days before the last date of admission i.e., on or after 16 th August 2025 till 31 st August 2025.	90% Refund
If withdrawal is made within 15 days after the last date of admission i.e., 1st September 2025 to 15th September 2025.	80% Refund
If withdrawal is made between 16 and 30 days after the last date of admission i.e., 17th September 2025 to 1st October 2025.	50% Refund
If withdrawal is made after 30 days from the last date of admission i.e., on or after 1st October 2025.	0% Refund
	If a student withdraws 15 days or more before the last date of admission i.e., before 16 th August 2025. If withdrawal is made within 15 days before the last date of admission i.e., on or after 16 th August 2025 till 31 st August 2025. If withdrawal is made within 15 days after the last date of admission i.e., 1 st September 2025 to 15 th September 2025. If withdrawal is made between 16 and 30 days after the last date of admission i.e., 17 th September 2025 to 1 st October 2025.

Note:

- A processing charge of 5% of the total fees paid, subject to a maximum of ₹5,000, will be deducted in all categories of refund. The applicable refund percentage will be calculated on the balance amount after this deduction.
- If a student has secured admission by paying only a token amount and later applies for cancellation, he/she must first clear all pending financial dues. The refund clause will apply only after settlement of such dues.
- If a student who is offered any scholarship decides to withdraw, he / she will be treated as a nonscholarship student and the withdrawal guidelines as given above will be applicable.
- The security deposit, which are not part of the fees chargeable, shall be refunded in full.

Refund of fees shall be processed by the Institution within 45 days of receiving a written application from the student.
